### 2023 LEGISLATIVE COMMITTEE ACTIONS

**VOTING ITEM R#2023-4**, pg 5 -- A Call to Promote Justice for Palestinians

**Legislative Committee 1 -- Chair:** Rev. Joel Pier-Fitzgerald **Recorder:** Rev. Carol Freeland

**Amendment #1:** Line 30, Add new last bullet -- "contact their United States Congressional representative and ask them to support passage of Defending the Human Rights of Palestinian Children and Families Living Under Israeli Military Occupation Act (H.R. 3103) introduced by Congresswoman Betty McCollum."

Action on amendment #1: Yes - 155, No - 10 (amendment passed)

Final Action: Yes - 156 (92%) No - 13

**VOTING ITEM R#2023-6, pg 7 -- Third Grade Reading Efficiency in Local Communities**

**Amendment #1:** Lines 31 & 32, delete last sentence -- "Such progress reports will become part of the annual report of the congregation as they celebrate local ministry with their respective community to the district superintendent."

Action on amendment #1: Yes - 142, No - 17 (amendment passed)

**Amendment #2:** Lines 28 and 29, item b -- insert "materials and" after pertinent; insert "early" after proficient; add at end of item b) "from Pre-Kindergarten through grade 2;"

Line 29, item c – replace "the meeting of reading goals for all 3<sup>rd</sup> grade students" with "enhancing fund of vocabulary words, letter identification, letter/sound relationships and reading for pleasure,"

Action on amendment #2: Yes -- 120, No -- 43 (amendment passed)

Amendment #3 SUBSTITUTE: Be it resolved that the Michigan Annual Conference will encourage each congregation to help local public school 3rd grade students achieve reading proficiency in the 2023-24 school year and beyond. This would include, but not be limited to, providing volunteers for tutoring from your congregation. The congregation, if they choose, can include the reading level of the 3rd grade class they are helping in their annual report. The proficiency information would come from The Michigan Student Test of Educational Progress or known as M\_Step Test...

Amendment #1 to Substitute – Replace "come from The Michigan Student Test of Educational Progress or M\_Step Test" with "be determined by current state measuring methods or other equitable tools".

Action on Amendment #1 to Substitute: Yes - 114, No -- 51

Action on amended #3 Substitute: Yes -- 77, No - 88 (substitute failed)

**Amendment #4:** Line 33, add at the end "Michigan United Methodists are also encouraged to work with their local school boards to strive for more effective reading curriculum."

Action on amendment #4: Yes -- 104, No -- 53 (amendment passed)

Amendment #5: Line 29, replace "2nd grade" with "3rd grade"

Action on amendment #5: Yes - 125, No - 27 (amendment passed)

**Amendment #6:** Line 23, replace "anticipates" with "encourages" and add at the end of the paragraph "The proficiency information would be determined by current state measuring methods or other equitable tools."

Action on amendment #6: Yes - 119, No - 39 (amendment passed)

#### FINAL AMENDED RESOLUTION:

- 23 Be it resolved that The Michigan Conference encourages that: every congregation of the Conference to engage with local school districts to discern needs pertinent to empowering every 3rd grade student to reach reading proficiency in the 2023-4 and subsequent school years. The proficiency information would be determined by current state measuring methods or other equitable tools.
- 27 This includes, but is not limited to: a) providing volunteers for tutoring or funding for the hiring of tutors, b) provide \$100 for the purchase of pertinent materials and books that empower proficient early reading from Pre-Kindergarten through 3rd grade, c) provide at least \$100 financial assistance for supplies needed to encourage enhancing fund of vocabulary words, letter identification, letter/sound relationships and reading for pleasure. Michigan United Methodists are also encouraged to work with their local school boards to strive for more effective reading curriculum.
