Motion of Board of Trustees to Approve Disaffiliating Congregations Corporate Session, June 3, 2023

WHEREAS, the General Conference of the United Methodist Church in February of 2019 passed ¶ 2553 of the Book of Discipline which provided a limited avenue for UMC congregations to disaffiliate from the UMC if by reason of conscience they could not abide by the UMC's current or potential stance related to LGBT+ persons; such ¶ 2553 to expire on December 31, 2023;

WHEREAS, ¶ 2553 mandates the Conference Board of Trustees to provide a Disaffiliation Agreement for Conference congregations based on a General Council on Finance and Administration template with terms provided by ¶ 2553 and such other terms as are not inconsistent with ¶ 2553; the Michigan Conference Board of Trustees has prepared and provided such Disaffiliation Agreement;

WHEREAS, major requirements of the Disaffiliation Agreement include:

- a. Two-thirds vote in favor of disaffiliation at a duly called Church Conference;
- b. Payment of disaffiliation costs of:
 - 1) Equity Component of two times Ministry Shares, unless waived
 - 2) Unpaid Ministry Shares for the previous 12 months
 - 3) Additional 12 months of Ministry Shares
 - 4) Pro-rata share of Aggregate Unfunded Pension Obligation
 - 5) Unpaid health and benefit balances
 - 6) Unpaid loans and obligations to United Methodist entities, unless assigned;
- c. Covenants concerning the retention of records and the use of intellectual property;
- d. Quitclaim deed from the Conference with the release of the Trust Clause;

WHEREAS, the congregations on the attached Addendum have held their Church Conferences and have voted to disaffiliate and are currently in the process of complying with the Disaffiliation Agreement, with all requirements to be completed prior to the Disaffiliation Date of July 1, 2023.

NOW, THEREFORE, IT IS RESOLVED that the Corporate Session of the Michigan Conference of the United Methodist church hereby approves the disaffiliation of the congregations listed on the attached Addendum for a Disaffiliation Date of July 1, 2023;

FURTHER RESOLVED, that approval of disaffiliation of these congregations is conditioned on the completion of all requirements of the Disaffiliation Agreement by the Disaffiliation Date of July 1, 2023 to the satisfaction of the Conference Board of Trustees.

FURTHER RESOLVED, that in the event a congregation does not satisfy the requirements of the Disaffiliation Agreement to the satisfaction of the Conference Board of Trustees by July 1, 2023, the congregation shall be notified and that congregation will be held over for another vote at the called Special Annual Conference Session of the Michigan Conference scheduled for November 30, 2023, for a possible Disaffiliation Date of December 31, 2023.
